SCOPE OF WORKS FOR NADARIVATU PROJECTS CADASTRAL SURVEY

1. Korolevu Weir

- Access to the Korolevu weir inclusive of main entrance gate.
- Korolevu Weir and intake.
- Korolevu Weir reservoir.
- As built survey of the Weir structure, access to the weir and other existing structures thereon

2. Tunnel

- AS built survey of weir alignment, intake and outlet structures
- Tunnel intake and outlet.
- Tunnel reserves.

3. Spoil Site

- Access to spoil site.
- Korolevu weir spoils site.

4. FEA Cam Site

- Access to FEA camp site.
- FEA camp site inclusive of FEA Camp, Storages Areas and Guard quarters, Fuel tank site
- As built survey of all existing FEA Camp, Storerooms, Guard quarters, fuel tanks and other built structures.

5. Water Pipe and Treatment and Pump House

- Water pumping spot at the Korolevu Weir
- Water pipeline easement
- Water treatment plant(house and implements site)
- Pipeline easement from treatment plant to FEA camps.
- As built survey of existing water mains, storage tanks and other built structures.

6. Ekubu Transmitter Site

- Access to transmitter site.
- Transmitter fenced area.
- As built surveys of Transmitter structures
- As built surveys of fenced areas

7. Surge Shaft

- Access to surge shaft

- As built surveys of Surge Shaft structure and fenced areas.

- Outlet structures inclusive of associated structures
- As built surveys of existing tunnel alignment and outlet structures

9. Penstock Route

- Access to Penstock route.
- Penstock reserves
- As built surveys of Penstock alignment.

10. Power House

- Access to Power house from Buyabuya gate.
- Power house inclusive of Powerhouse and Accommodations.
- Fenced areas.
- As built survey of Power House structures, fence and Guard house.

11. Outlet Spoil Site

- Access to outlet spoil site.
- Spoil site.

12. 132 KV Transmission Lines.

- Access to transmission towers.
- Tower sites
- Transmission easements
- As built surveys of Tower structures.

13. Switchyard Site.

- Access to switchyard.
- Switchyard site inclusive of main switching buildings and fenced areas.
- As built surveys of switchyard structures and fence.
