Preferred Supplier of Filters for FEA's Generators

FEA is seeking a preferred supplier for filters for its fleet of generators situated in power stations across Fiji. The supplier will be responsible for supplying genuine and reliable filters as and when requested ensuring the amount requested is supplied in due time before the generator operation is affected.

Note

1. Bidders are encouraged to price the filters according to generator models specified.
2. The price stated should be delivery price (inclusive of freight and other handling costs).
3. Delivery times to be stated as well.
4. Filter specification sheets should be included together with product guarantee.
5. Supply of filters will be done on a continual “as per need basis” – basically during maintenance periods on specific engines. Hence delivery times play an important role in ensuring that the generators are operational in the shortest time available – bidders hence should have adequate stock present to meet demands.
