THE COMPANY - EFL

Energy Fiji Limited (EFL) is a limited liability company that was established under the Companies Act (2015), Laws of Fiji. It is supervised by a Board comprising a Chairman, Deputy Chairman, the Chief Executive Officer and representatives from its shareholders.

EFL is primarily responsible for generation, transmission and distribution of electricity in Viti Levu, Vanua Levu, Ovalau and Taveuni in Fiji. It owns over twenty (20) power stations and forty (40) substations and switching stations on the islands of Viti Levu, Vanua Levu, Taveuni and Ovalau. EFL owns, operates and maintains a network of 147km of 132kV transmission lines, 534.86km of 33kV lines and over 9,810km of 11kV and 415V distribution lines including approximately 30km of single wire earth return system, as at 31st December 2019. By the end of December 2021, EFL had over 210,831 customers. This included residential, commercial and institutional customers.
