Technical Specifications for Lever Block

1. General Description

The preferred supplier is to supply Energy Fiji Limited with the Lever Block (also known as Lever Hoist). The bidder's proposal shall address all functional and performance requirements within the specification and shall include sufficient information and supporting documentation in order to determine compliance with this specification without further necessary inquiries.

The tender for Preferred Supplier of Lever Block for Network Distribution Department of EFL will be awarded for a supply period of 2 (Two) years as the preferred supplier. EFL will purchase the required quantity as per need basis for a **fixed price** for next 2 (Two) years.

EFL is looking at three different load rating of the Lever Block:

- 0.75T Three Quarter Ton
- 1.5T One and Half Ton
- 3T Three Ton

3. Delivery

Maximum allowable delivery time to be 1 week from issue of Purchase Order.

4. Warranty

The bidder is to also state warranty details and submit in their tender submission. The required warranty period is 1 (One) year from the date of receipt of items. Warranty shall cover free repair works for faulty/defective equipment within the 1-year period and/or replacement of lever block/hoist where repairs prove ineffective or cannot be done. Any lever block found defective within 2 weeks of usage shall be replaced with a new unit.

5. Price Validity

The prices must be valid for a minimum of 3 months from date of close of tender. In exceptional circumstances, EFL may solicit the Bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing.

EFL reserves the right to order more units under the same contract at the cost agreed to as per need basis for a period of **Two (2) year.**
