1.0 General Descriptions

Energy Fiji Limited intends to purchase quality, durable and reliable Cordless Angle Grinders for the Distribution team in the Central Division. Bidders are required to submit proposals that thoroughly address the specifications, providing adequate information and supporting documents to verify compliance.

The supplier is to supply each unit complete with all recommended accessories as stated in the particulars in the specifications below.

3.0 Packaging and Marking

The packaging of items by the bidder must ensure that they are capable of being delivered undamaged giving due consideration to the quantity, distance of transportation and the preferred method of handling at each location.

- Item Description

4.0 Quality Requirements

Tenderers are required to submit evidence that the design and manufacture of Cordless Angle Grinder are in accordance with AS/NZS ISO 9001 and shall include the Capability Statement associated with the Quality System Certification.

If the Tenderer is a non-manufacturing supplier, the documentary evidence shall include the quality system certifications of both the supplier and the manufacturer.

5.0 Product Warranty Period

The bidder is required to provide the warranty period as part of the proposal. A minimum warranty period of 1 (one) year from receipt time of item(s) at EFL shall be provided.

6.0 Delivery

The bidder is to state the estimated time of delivery from issue of purchase order (preferably 4 weeks from the issue of purchase order). Maximum allowable delivery time to be 4 weeks from issue of Purchase Order. The items to be delivered to Energy Fiji Limited's Kinoya depot.

7.0 Maintenance and Servicing

The supplier should be available for the comprehensive maintenance and servicing of the tools. The maintenance and servicing activities shall be conducted in accordance with best industry practices manufactured recommendations and applicable regulations. All spare parts, components and materials used for maintenance shall be of highest quality. Payments for maintenance and servicing shall be as per the agreed upon terms in the contract.
