| 2. Eligible Bidders | The successful bidder will be expected to supply machinery on hourly basis for a minimum of 3 years. |
| | This invitation to bid is open to bidders who have sound financial background and have previous experience in this area. |
| 3. Cost of Bidding | The bidder shall bear all costs associated with the preparation and submission of its bid and the Purchaser will in no case be responsible or liable for those costs. |
| 4. Tender Submission | It is mandatory for bidders to upload a copy of their bid in the TENDER LINK Electronic Tender Box no Later than 1600hrs, Wednesday 30 October, 2024. To register your interest and tender a response, view 'Current Tenders' at: https://www.tenderlink.com/efl |

The Employer may, at its discretion, extend the deadline for submission of bids by issuing an addendum, in which case all rights and obligations of the Employer and the bidders previously subject to the original deadline will thereafter be subject to the deadlines extended. |
| 6. Late Bids | Any bid received by the purchaser after the deadline for submission of bids prescribed will be rejected and returned unopened to the bidder. |

 The Employer reserves the right to accept or reject any bid, and to annul the
 bidding process and reject all bids, at any time prior to award of Contract,
 without thereby incurring any liability to the affected bidder or bidders or any
 obligation to inform the affected bidder or bidders of the grounds for the
 Employer's action.
- 8. Notification of Award
 Prior to expiration of the period of bid validity prescribed by the Employer, the Employer will notify the successful bidder by fax/email, confirmed by registered letter, that its bid has been accepted. This letter (hereinafter and in the Conditions of Contract called the "Letter of Acceptance") shall name the sum which the Employer will pay the Contractor in consideration of the execution, completion and maintenance of the Works by the Contract called "the Contract Price").

The notification of award will constitute the formation of the Contract.

Upon the furnishing by the successful bidder of a performance security, the Employer will promptly notify the other bidders that their bids have been unsuccessful.

 At the same time that he notifies the successful bidder that its bid has been accepted, the Employer will send the bidder the Form of Contract Agreement provided in the bidding documents, incorporating all agreements between the parties.

Within 7 days of receipt of the Form of Agreement, the successful bidder shall sign the Form and return it to the Employer.

- 13.Corrupt or
Fraudulent
PracticesThe Employer requires that the Contractor observe the highest standard of ethics
during the procurement and execution of such contracts. In Pursuance of this
policy, the Employer:
 - (a) defines, for the purposes of this provision, the terms set forth below as follows:
 - (i) "corrupt practice" means behavior on the part of officials in the public or private sectors by which they improperly and unlawfully enrich themselves and/or those close to them, or induce others to do so, by misusing the position in which they are placed, and it includes the offering, giving, receiving or soliciting of anything of value to influence the action of any such official in the procurement process or in contract execution; and
 - (ii) "fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Employer, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Employer of the benefits of free and open competition;
 - (b) Will reject a proposal for award if it determines that the bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.

1.0 General Description and Work scope

The supplier is to provide the following heavy machinery on an hourly basis for the formation of access road access, pole pit digging and other works required by EFL in the Central Division.

• 12 Ton excavator with Batter Bucket, Rock Bucket and Rock Breaker Attachment

The contractor shall be solely responsible for all associated costs for the execution of works such as transportation of fuel and operator to site for the execution of works as requested by EFL representative.

The anticipated work scope to be executed by the heavy machinery includes:

- Formation of Access Road
- Carry out landscaping for line structures and other works.
- Digging pole pit holes.
- Digging trenches for underground cables and faults.
- Construction of new drainage and side parking zones
- Rock breaking works to enable the construction of new drainage and formation of access roads.

Payments for works shall be made on a rate to measure basis (hourly rate).

Bidders are requested to provide the following documentations for the evaluation purposes:

- 1. Proof of ownership of Excavator
- 2. Documents stating the condition of the Excavator and rock breaker attachments with Pictures
- 3. Business Registration Certificate
- 4. Copies of operator's licenses
- 5. OHS Compliance
- 6. Works previously carried out for EFL or any other companies.

- 8. FNPF Compliance Letter
- 9. Tax Compliance Letter

Note. The bidder must avail all its relevant machineries for inspection by EFL personnel.

- The contractor will be responsible for the security of machinery if left at site overnight.
